

## Job Description: Early Childhood Education / Preschool Teacher San Francisco Bay Area, California

We are seeking Preschool / Early Education Teachers for the upcoming school year. Applicants should be strong team players and be very proactive and flexible. Final candidates need to be prepared for a teaching demonstration (or a video if they are overseas).

This position will report to the Early Childhood Director at our campus in San Francisco's Dogpatch neighborhood.

#### Role responsibilities

- Set educational and developmental goals for the children in your group, both as a group and individually.
- Prepare the environment (indoor and outdoor) thoughtfully every day so that it supports those objectives.
- Plan (progettazione) & carrying out appropriate daily curriculum and long term projects to further support those goals.
- Assess and document the group dynamic, as well as individual developmental progress toward group and individual goals is required.



• Effectively communicate with staff and parents; a weekly bulletin (Momenti) describing classroom activities is required for all classes. The weekly bulletin will also explain why the described activities are chosen and what children are learning through them.

#### <u>Qualifications</u>

- Bachelor's degree in Education, or Child Development Certificate, or 5+ years experience working with children required;
- Experience working in a Reggio Emilia inspired school
- Bilingual and bi-literate in Italian and English with native or near-native Italian proficiency;
- 4 core classes\* of early childhood education:
  - Introduction to the Field of Child Development (3 units) CDEV 65
  - Child Growth and Development (3 units) CDEV 53
  - Child, Family and Community (3 units) CDEV 67
  - Curriculum for Young Children (3 units) CDEV 66
- Must be authorized to work in the U.S. See note below regarding potential J-1 visa sponsorship requirements.

## Required Skills and Pre-requisites

- Fluency in reading, writing and speaking in English/Italian;
- Knowledge of Reggio Emilia approach;
- Familiarity with IB-PYP Curriculum framework or inquiry/project based approach;
- Excellent verbal and written skills, as well as outstanding interpersonal skills;
- Problem solving, creativity, excellent multitasking skills, and ability to thrive in a start-up environment are a must.
- Ability to plan curriculum, lead other teachers;
- Excellent communication skills and ability to present in public to both parents and other educators;
- Enjoy working with children, including ones with mild learning differences;
- Ability to work well in a team and in a very collegial and collaborative environment;
- Willingness to be an active, enthusiastic member of the La Scuola community;
- Obvious passion for the academic subject matter being taught;
- Commitment to equity, inclusion and a diverse community;
- Excellent attendance and punctuality.

Prior to beginning work and as a condition of employment in order to comply with the law, all employees must provide documentation to prove eligibility to work in the United States.



In addition, the final candidate will need to pass both Criminal Justice Department and Federal Bureau of Investigation Fingerprint Clearance and a physical exam, and provide a recent copy of a negative TB test and other immunization records.

#### <u>Benefits</u>

Estimated annual salary range: \$62,400 to \$124,000 depending on credentials, qualifications and experience. Position receives excellent benefits, including medical, vision and dental coverage. The school also offers group life insurance, employer-matched retirement, long-term disability insurance and commuter benefits. #### J-1 Visa Sponsorship Opportunities

Depending on qualifications and experience, candidates may be eligible for a J-1 teacher sponsorship if the below requirements are met:

- J-1 visa federal regulations require foreign teachers to:
- (1) qualify to teach in K-12 schools in their country of nationality or last legal residence



(2) have two years' full-time teaching experience

(3) satisfy the standards of the US state where they teach

(4) be fluent in English

(5) be of good reputation and character

(6) teach full-time 32 hours per week minimum in the US

(7) possess the equivalent of a US university degree (4 years) in education or subject taught

(8) be currently working as a teacher in home country or country of last legal residence

(9) Exchange Intent-to come to the U.S. for the purpose of exchange, not work. CANNOT:

(10) work as a principal, intern, tutor, counselor, coach, etc. per CFR 62.24 Guidance 2019-01[2], Feb 1, 2019

(11) have worked in J-1 teacher visa status in the US during the previous 2 years

(12) work in day-care schools

(1) qualificarsi per insegnare nelle scuole K-12 nel loro paese di nazionalità o ultima residenza legale

(2) avere due anni di esperienza di insegnamento a tempo pieno

(3) soddisfare gli standard dello stato degli Stati Uniti in cui insegnano

(4) essere fluenti in inglese

(5) essere di buona reputazione e carattere

(6) insegnare a tempo pieno minimo 32 ore settimanali negli Stati Uniti

(7) possedere l'equivalente di un diploma universitario statunitense (4 anni) in materia di istruzione o materia insegnata

(8) sta attualmente lavorando come insegnante nel paese di origine o nel paese di ultima residenza legale

(9) Intenzione di scambio: venire negli Stati Uniti a scopo di scambio, non per lavoro. https://cordellhull.com/faqs/
